#### 1. Apologies

#### 2. Declarations of Interest.

Cllr Cox declared her personal interest in the Planning Application 0552/11 on the Agenda as she lives next door to the site. Otherwise as recorded in the Register.

### 3. To approve the Minutes of the Meeting held on 18<sup>th</sup> October 2011.

The minutes were agreed as accurate and signed by the Chair.

#### 4. Matters arising from the Minutes of the Meeting held on 21<sup>st</sup> June 2011.

Cllrs advised that there had been a village meeting for the Diamond Jubilee Celebrations and that it is requested that the Parish Council contribute in some way financially. It was agreed to discuss a sum under the Finance Item on the Agenda.

#### 8. Planning Applications.

0552/11 Proposed erection of new dwelling and relocation of playing field to rear of school at The School, School Road, Lydford.

Councillors discussed their objections so far to the application taking into account the concerns raised at the beginning of the meeting. It was agreed to formally respond to DNPA after the closed site meeting scheduled for later this week.

#### 9. Correspondence.

a) Modification order for Bridleway No 52 & Footpath nos 41, 49 & part of 10, Lydford.

Correspondence had been received both in support and objections to the order. Councillors discussed and agreed to object to the order on the following grounds: they felt that the evidence was possibly flawed and misinterpreted, some evidence was submitted after the close of the consultation period, disproportionate weight to supporting evidence, insufficient evidence to support the order, not enough consideration given to evidence and witness statements/correspondence that opposed the application for the upgrade. Cllr Moriarty thanked Mrs Law for referring the Parish Council to the Planning Inspectorate Guidelines (information that had not been forthcoming from Devon County Council).
